Through the child sponsorship program, World's Children sent monetary aid in the form of child sponsorships to approximately 1200 children in 48 orphanages in India, Kenya, Phillipines, Guatamala, Panama and Mexico, to ensure that at-risk children living in the orphanages we support will receive nutritious food, clean and warm clothes, medical care, a good education and perhaps most important—a safe and loving environment in which to grow up.

In addition, scholarships were provided to 66 college-age students, primarily from India, to attend colleges to study various topics including Nursing, Operating Room Technology, Engineering, Business Administration,
