- Periodic reports and photos

applications for college scholarships.

We have regular monthly contact by phone, email and post. The home or its parent organization must have government sanctioned charitable status and be allowed to receive funds, such as FCRA status in India.

Beginning in 2010 World's Children contracted the services of a nonprofit in India called the Spandana Society to help us monitor, evaluate and communicate more effectively with the orphanages and hostels we support in India.

Scholarships: The 33 orphanages assisted by World's Children help us publicize the availability of scholarships. Another significant contributor to the scholarship process is a nursing school, the ETCM Hospital School of Nursing in Kolar, India. World's Children also supports the Sacred Heart College of Nursing in Dindigul, India.

Child Sponsorship: Through the child sponsorship program, World's Children sent monetary aid in the amount of \$231,982 for the care of approximately 946 children in 33 orphanages in India, Ethiopia, and Guatemala. This support ensures that children living in the orphanages we support receive nutritious food, clean & warm clothes, medical care, a good education, and a safe and loving environment.

Healthy Child Fund: In 2018, World's Children supported a Healthy Girl Initiative at Balavikasita Orphanage in India that was funded by The Rosie Center in the amount of \$1716 to help girls through puberty. The girls received education and support, supplies, added nutrition, and doctor visits. This successful pilot project began in the fall of 2016.

Scholarships: World's Children aims for successful outcomes through our scholarship program for disadvantaged young men and women. In 2018, World's Children provided scholarships for 259 students for a total of \$133, 840. This includes children who come up through our sponsorship program and other needy students at two nursing colleges where we support the most vulnerable students. In 2018, 92 students graduated with degrees in Nursing, Hotel Management, Engineering, Banking and Accounting, Computer Technology, Vocational Training and Teaching.

Projects: World's Children also provided \$108,816 for special projects to improve the infrastructure at the orphanages we support. These projects positively affected the 768 sponsored children and over 3,350 unsponsored children living at these orphanages and enjoying the benefits of the projects and programs we support. These projects

facility, roof construction, mosquito nets and beds for three orphanages, four computers, printers, and one copy machine to five homes, an industrial washing machine, one library, large water filtration for Home for blind children, tables and chairs, lockers, playground equipment, toys, a refrigerator, a TV with DVD player, fans, two sewing machines, a bread machine, a large compound wall for one orphanage, security cameras, and orphanage repairs.

Prevention of Child Trafficking Project is a three-year project started in April 2017. This project will provide 30,000 people in villages in India with the knowledge about how traffickers dupe women or simply snatch unwatched girls. The goal is to stop child trafficking in this targeted area, which has a total population of about 151,000 people. A group of Catholic nuns is facilitating this project. We have worked with them for several decades and we currently support five orphanages that they operate. In 2018 we provided \$14,102 for this project.

Disaster Relief for the Kerala Flood: Through our trusted contacts in the region, World's Children was able to provide \$2,750 to provide critical supplies for victims of the 2018 large scale flood in a particularly hard-hit village in Kerala, India.
